The Two Rivers Public School District does not intend to set spacing needs when acting on open enrollment applications for regular education applications. The Two Rivers Public School District has projected that there will be no open spaces for EC/4K through Secondary Special Education Services. To determine space availability, DPI uses a formula to determine acceptable caseload size. Our district looks at the student to teacher ratio and if it exceeds the number set by DPI, the program is closed; motion carried 6-0.
