Facility/Technology Committee Minutes, May 12, 2022

The meeting was called to order by Williams at 4:45pm.

- 1. District news / updates-Engh discussed a future possibility of a Two Rivers High School addition strictly through donations and would not take anything from the possible referendum. A local company is inviting us to "dream bigger" for tech ed, CAD lab, paint booth, Raider Mfg., athletic areas needing updating, etc. A permanent dome similar to the Hodag Dome in Rhinelander was discussed. Johnson will contact the Rhinelander school district to ask for life expectancy of such a structure, maintenance and utility costs, revenue generated, etc.

Discussion took place on pool current and future use. TR Rec Dept and summer school not using the pool this summer due to lack of lifeguards. Further discussion will need to take place.
