 - A. Updates from administrative units
 - ◆ Lisa Quistorf thanked the staff for a smooth ending to the school year. Tonight we approved an L.B. Clarke Guidance Counselor and we will need to add a full-time EBD teacher at Magee Elementary School. We will need to hire someone with specific skills. This will be on the next agenda. Bridgett Klein reported that the elementary and high school staff is working on curriculum. The early childhood staff is hosting a Literacy Night at the Lester Library on June 27th from 5:30 − 7:00 p.m. that includes dinner, child care and a free book. Bridgett has been busy writing grants including the ES3 Grant that has a 3-year commitment. The money will be used for coaching/training and resources. Justin Litersky talked about the Raider Pride Program, which is a pathway for students who have difficulty with a 7 hour school day and are credit deficient with an IEP. Students will need to provide a statement as to why they want to join the Pride Program. Nine students have been identified for the 2018-2019 school year.
