Committee of the Whole Board Meeting - June 25, 2018

- 1. The meeting was called to order by President Salta at 6:32 p.m.
- 2. The following members were present: Commissioners Jennifer Harteau, Zak Peterson, Maria Veldre, Randy Williams and Jaimie Salta. Commissioners Greg Ross and Julie Schroeder were excused.
- 3. Written notice of this meeting was sent to the news media on Friday, June 22, 2018.
- 4. The Pledge of Allegiance was recited.
- 5. Motion by Com. Harteau, seconded by Com. Williams, to approve the agenda as posted; motion carried unanimously.
- 6. Recognition of invited visitors and guests: Summer School Principal Alex Ourada reported that there are approximately 970 students enrolled in Summer School and 120 staff members with 70 courses. Students presented their fidget projects from Make It, Take It and Play It and their robots from the Cool Junk class. Theater students also provided information on their upcoming Musical, *Frog and Toad Kids*.

  - A. The Two Rivers Public School District received The Excellence in Energy Efficiency Award today. We are the only school in the state to receive this award. We have saved more than \$42,000 with the changes that have been made using LED lighting. Chad Bauknecht reported that there are 84 children registered for 4K for 2018-19; however, that number will likely increase closer to the start of school. Bob Bauknecht reported on the progress of the renovations in the academic wing at L.B. Clarke and stated it should be completed by July 13<sup>th</sup>.
