- L. Motion by Com. Ross, seconded by Com. Harteau to approve the permanent easement agreement in the amount of \$6,700 to the City of Two Rivers for the purpose of maintaining a Bicycle and Pedestrian Trail; motion carried unanimously.
- M. Motion by Com. Harteau, seconded by Com. Ross to approve the return of easement payment of \$6,700 to the City of Two Rivers for the Bicycle and Pedestrian Trail Project; motion carried unanimously.

Rick Miller and Erin Gruwell will present at the District-Wide Inservice on August 20th. School Resource Officer update was provided.
