- 1. The meeting was called to order by President Jaimie Salta at 6:30 p.m.
- 2. The following members were present: Commissioners Michael Canty, Zak Peterson, Gregory Ross, Julie Schroeder, Maria Veldre, and Jaimie Salta. Commissioner Randy Williams was excused.

- 5. Motion by Com. Schroeder, seconded by Com. Ross, to approve the agenda as posted; motion carried unanimously.
- 6. Recognition of invited visitors and guests: Mrs. Pautz, Koenig second grade teacher, provided an update on students working on Phonics & Writing with Lucy Calkins where students are learning with Choice Boards for Reading. Mrs. Blashka, Behavioral Specialist at L.B. Clarke provided information on the STEAM group (Science, Technology, Engineering, Art and Math). The group is working with Grow it Forward out of Manitowoc. The students in this group are recycling bags and making hanging bird feeders, planting seedlings. They built a grow tower and planted seedlings.
