Committee of the Whole Board Meeting - January 27, 2020

- 1. The meeting was called to order by President Jaimie Salta at 6:30 p.m.
- 2. The following members were present: Commissioners Jennifer Henrickson, Julie Schroeder, Maria Veldre, Randy Williams and Jaimie Salta. Commissioners Zak Peterson and Gregory Ross were excused.
- 3. Written notice of this meeting was sent to the news media on Friday, January 24, 2020.
- 4. The Pledge of Allegiance was recited.
- 5. Motion by Com. Schroeder, seconded by Com. Veldre, to approve the agenda as posted; motion carried unanimously.
- 6. Recognition of invited visitors and guests: L.B. Clarke 8th Grade Teacher, Mrs. Gauthier, along with students presented to the Board the formation of rock using Starburst. TRHS Student Government Representative, Wil Schmid, also gave an update on events since the start of school, including, Homecoming with 350 students attending, the Blood Drive with 30 people and the Halloween Carnival that raised \$422.00 for TREP. He also announced Student Wellness Day will take place on February 14th and Blood Drive on March 11th.

10. District Administrator's Report:

A. Adam Rohrer provided a facility update stating that the pool heater will be replaced next week and the quote for repair is \$5,300. He reported that the roof projects will be done by sections and the project will be broken down by cost. He also reported to the Board that a new salter for the back of the truck was purchased and safety, high visibility jackets were purchased for his staff for working outdoors. Craig Rysticken reported that there will be a Trap Team meeting on Saturday morning at 9:00. The Winter Dance will take place on Saturday evening and the cost is \$5.00; there will be a DJ and prizes. Dana McLinn reported that she and Bridgett Klein will attend the Impactful Academy Coaching seminar. Koenig Elementary Spirit Week kicked off today and there is an allschool assembly on Wednesday. PLC meeting by grade level will also take place on Wednesday. February 7th marks the 100th day of school. Chad Bauknecht announced that his Reading Celebration Week will be "We Read - What's Your Super Power?". On Wednesday Mrs. Weiler's class will help facilitate the Minute to Win It game. Tim Wester reported that the sixth annual Spelling Bee recently took place with Jade Cowdery the winner and she will now compete in Regionals next week. The ACP Team met last week and are planning for the end of 3rd Quarter Career Day. There will be 20-25 presenters on diverse career paths. Next year the plan is to work with Joy Jirikowic and the Chamber for a Reality Store for Middle School. There will be an 8th Grade Courage Retreat on Wednesday with a group from Minnesota called Youth

Frontiers. They will talk about how peer pressure affects your actions, self, community and school. An L.B. Clarke Community Meeting was held in December and another on Monday. Communication between family and school was stressed. If more resources are needed, please talk to counselors, principal, Lisa Quistorf or the Board. How issues are addressed involves restorative practices (owning actions and making it right). A discussion on dogs in school also took place at the meeting.
