



TWO RIVERS PUBLIC SCHOOL DISTRICT
BOARD OF EDUCATION
Committee of the Whole Board Meeting – November 23, 2020

1. The meeting was called to order by President Jaimie Salta at 6:30 p.m.
2. The following members were present for this virtual meeting via Zoom: Commissioners Michael Canty, Zak Peterson, Julie Schroeder, Maria Veldre, Randy Williams and Jaimie Salta. Commissioner Gregory Ross was excused.
3. Written notice of this meeting was sent to the news media on Friday, November 20, 2020.
4. The Pledge of Allegiance was recited.
5. Motion by Com. Peterson, seconded by Com. Veldre, to approve the agenda as posted; motion carried unanimously.
6. Recognition of invited visitors and guests: Maren Slickman, Program Support Teacher and Coach; Kristin Cwiak, SLP; and Ashley Jagemann, ID Teacher, presented information on the ES3 Grant. This is a program that enhances sensory, social and emotional, and self-regulation skills in children with Individualized Education Plans (IEPs). Tim Wester and Alex Ourada also provided information on the school year at L.B. Clarke. Students are using file boxes in place of lockers so all of the things they need throughout the day are with them in their classroom. They showed how teachers are incorporating both classroom and eLearning for students simultaneously. The Golden Raider is a new award that started this year and is awarded to both staff members and students. When a staff member receives the award, they will then pass it on to a deserving student and in turn the student will pass the award on to a staff member.
