Regular School Board Meeting – March 8, 2021

1. The meeting was called to order by President Jaimie Salta at 6:30 p.m.
2. The following members were present: Commissioners Michael Canty, Zak Peterson (via Zoom), Gregory Ross, Julie Schroeder, Maria Veldre, Randy Williams, and Jaimie Salta.
3. Written notice of this meeting was sent to the news media on Friday, March 5, 2021.
4. Pledge of Allegiance.
5. Motion by Com. Ross seconded by Com. Canty, to approve the agenda as posted; motion carried unanimously.
6. Motion by Com. Canty, seconded by Com. Ross, to approve the minutes of the Regular School Board Meeting of February 8, 2021 and the Committee of the Whole Board Meeting of February 22, 2021; motion carried unanimously.
7. Recognition of invited visitors and guests: None.
8. Questions and comments from citizens on agenda items: None.

10. Financial Statements:
 - A. Motion by Com. Ross, seconded by Com. Schroeder to approve February bills in the amount of \$1,076,129.32; motion carried unanimously. Motion by Com. Veldre, seconded by Com. Schroeder, to file activity funds and financial statements; motion carried unanimously.

12. Old Business:
 - A. Pupil Services: Building Principals along with Dr. Colleen Timm from CESA 7 provided an in-depth review on the district's strategic plan using a whole-child approach to address gaps in achievement and improve outcomes for all students.
 - B. School/Community Health, Fitness, Wellness & Recreation Coordinator: Discussion took place regarding this new position. The importance of developing the whole child, and providing equitable opportunity for all students was discussed. It was suggested that Phy Ed teachers could work with students. Brian Gallagher stated that this can't be filled with extra hours. We need someone committed to this role to build inclusion, sense of pride and commitment.

 - A. Motion by Com. Ross, no second, to Rescind Approval of School/Community Health, Fitness, Wellness & Recreation Coordinator; motion failed.
14. District Administrator's Report:
 - A. Lisa Quistorf talked about the reopening plan following CDC guidelines. Masks will be required and students at L.B. the March 22nd Board meeting. Dana McLinn and Chad Bauknecht reported that Reading is Fundamental (RIF) kicked off last week and the theme is Superheroes are Everywhere!
