12. District Administrator's Report:

- A. Jeremy Wildenberg of CESA 7 provided information on the Workforce Plus Program. The intention is to allow employees to work in the district they worked prior to retirement. Tim Engh provided information on his meeting with City Manager Greg Buckley. They are hoping to have students on the Environmental Advisory Board to get students involved in our community. Tim Wester and Dana McLinn reported on the ELA K-4 and 5-8 meeting with CESA 7 and Charla Meyer. They will have a pilot program next year and have high expectations to grow student's love of reading. Chad Bauknecht reported that the District has hired 25 new substitute teachers since Covid began. Lisa Quistorf discussed the reopening plan and stated that the guidelines we are following were put in place with information from a team of teachers, school psychologist, social worker, Department of Human Services, Department of Public Instruction, Centers for Disease Control, and the American Academy of Pediatrics, All of the information we are receiving states the importance of wearing masks through the end of the school year and summer. The information we follow is fact-based from medical organizations. Many times on social media you find opinions, but we will follow facts. Two Rivers should be a model of keeping kids in school. It was reported that the Washington House has a memorial plaque from Washington High School that should be displayed at TRHS. This will be discussed at the next Board meeting. Stacy Watzka informed the Board that they have provided free breakfasts and lunch since March and will continue until the end of 2021. Meals will be available on Monday, Wednesday and Friday at Koenig and Magee this summer. The Two Rivers Public School District partnered with the Two Rivers Ecumenical Pantry to distribute meals to families. The Food Service Department also received a letter from DPI that their fund balance is above the limit and they will need to spend some of it on equipment. They will spend \$60 - \$70,000 to replace dishwashers and warmers in the kitchens.
