- 5. Motion by Com. Veldre, seconded by Com. Williams, to approve the agenda as posted; motion carried unanimously.
- 6. Motion by Com. Williams, seconded by Com. Schroeder to approve the minutes of the Regular School Board Meeting of July 13, 2020, Facility Committee Meeting of July 20, 2020, Policy Committee Meeting of July 20, 2020, Special Board Meeting of July 23, 2020, and Committee of the Whole Board Meeting of July 27, 2020; motion carried unanimously.

- 10. Financial Statements:
  - A. Motion by Com. Williams, seconded by Com. Peterson, to approve July bills in the amount of \$1, 267, 554.53; motion carried unanimously.

  - A. Motion by Com. Williams, seconded by Com. Peterson to approve Teacher Contracts for Mariah Honeck, Band Instructor at TRHS and Carey Schmid, Math Instructor at TRHS; motion carried unanimously.
- 14. District Administrator's Report:
  - A. The Reopening Plan is a fluid plan pending guidance from the Wisconsin Department of Public Instruction. Chad Bauknecht reported that Koenig and Magee will be a one room school model with grade level teachers in class Monday through Thursday. Friday is a day for teacher collaboration and planning. Students will eat their breakfast and lunch in their classrooms. Google Classroom will be set up for all and face coverings will follow state and health guidelines. Physical Education will be part of recess activity. Parents and visitors will not be allowed in school. There will be staggered arrival and dismissal times. Tim Wester

reported that L.B. Clarke will have a blended/hybrid setting. The teachers will move from classroom to classroom, not the students. The Purple Group will meet on Monday and Tuesday and the Gold Group will meet on Wednesday and Thursday. There will be three recess times: one in the morning, one at lunch and one in the afternoon. Face coverings are required. Tim Engh reported that TRHS students will travel between classes due to the mixed grades in each class. TRHS and LBC worked together to have families attending school on the same days. Students will have their lunch in the cafetorium, tables set up in the hallway or outside. Students will be shown how to appropriately wear and remove masks. Bridgett Klein reported that teachers will be meeting this week to review students with disabilities needs including the level of engagement of eLearning and students' progress of IEP goals. Jaimie Salta thanked Lisa Quistorf and the staff for the monumental task in the reopening plan during this crisis. Adjustments may be made along the way.
