Glaser provided updates on what the School Resource Officers are working on: Officer Zipperer at TRHS is teaching Intro to Criminal Justice with the History of Law Enforcement and who they are. L.B. Clarke is planning their ALICE Drill training. Officer Glaser stated that he saw many students over the summer at the beach and parks. He is working on the Intruder Drills and using the book "I'm Not Scared I'm Prepared". In the near future he will talk through the drill with kids in the classroom. He is looking forward to a safe and great school year. Jake also informed the Board the City is working on an ordinance for vaping to address consequences. Bridgett Klein talked about Allies in Mental Health. She reported that the teams met in summer to discuss universal design, mission vision and goals.
